### Request for Continuing Education Units

#### In-person June Class

#### **For students:**

The Summer Curanderismo Traditional Medicine **in-person class** entitles you to receive **4.5 Continuing Education Units** after submission of a final reflection. 1 unit per 10 hours of classroom instruction.

#### **During the class:**

You will write a daily reflection for each of the days of class. You will submit a final portfolio containing each of your daily reflections. Please see syllabus for details and guidelines for your reflections.

#### **Upon completion of the 2-week class:**

Please submit your final portfolio of daily reflections **no later than** the stated deadline in the syllabus. There is no need to submit the reflections on a daily basis but only once upon completion of the course. After submission, Professor Del Angel-Guevara will report your successful completion to UNM Continuing Education.


#### **After submission of final portfolio:**

UNM continuing education will send you an official certificate issuing the 4.5 CEUs.

#### **After receiving the certificate:**

You will send the CEU certificate to your licensing board/employer together with the syllabus/calendar for this class. The licensure board/employer will determine how many CEUs to award based on what they consider relevant to their discipline.

There is no need to submit the reflections on a daily/weekly basis but only once upon completion of the course. After submission, Professor Del Angel-Guevara will report your successful completion to UNM Continuing Education.
